- CALL TO AUDIENCE:** **A. Pre-Audit Meeting with Board Members - Lori Fenstemaker, CLA (CliftonLarsonAllen LLP)**
The audit will begin October 1st with an on-site visit the week of October 17th. There will not be a single audit this year as federal grants did not surpass the required minimum.
- B. Opening of School 2024-2025 - Carlos Armendariz, Principal, and Erika Fragozo, Assistant Principal**
Nosotros Academy is hosting the second year of an EMT program

for Career Technical Education (CTE), spearheaded by LD Gomez. The EMT program is also linked to HOSA, a club focused on leadership in healthcare careers.

Twelve seniors are enrolled in Writing 101, a dual enrollment course through Pima Community College, and eighteen freshmen are taking dual enrollment Spanish.

Mr. Speelman is piloting an AP United States History course, which allows students to test for college credit.

Additionally, Nosotros is partnering with the Arizona Student Opportunity Collaborative (AZSOC) to offer senior math using a qualified instructor from another school.

This year, Nosotros Academy has implemented a new phone policy where students turn in their phone at the beginning of the day to increase engagement and improve student scores. So far, it has had a positive impact.

Enrollment is nearing an all-time high at 322 students. Nosotros Academy has continued to foster a relationship with El Rio Community Center, hosting a Basketball and Nintendo Switch elective at El Rio. Kindergarten is still housed at El Rio with a larger classroom.

Teachers at the K-6 level have been integrating strategies from the University of Arizona's professional development hosted over the summer, including the use of vertical non-permanent writing surfaces. Sports are now available to younger students so that they can learn skills until they are eligible to play.

Due to increased enrollment and the influx of special education and English language learner students, we are considering hiring an interventionist. Teachers are being trained in Response to Intervention (RTI) to best serve these students.

The sports season has begun with flag football and volleyball. The flag football team had their first game on September 10th with

volleyball having theirs on September 11th. There has been high participation in both sports across all grade levels.

C. Nosotros EMT/HOSA Students - LD Gomez

LD introduced the second-year EMT students, who are a part of Health Occupations Students of America (HOSA). While students learn hard skills through EMT, they will learn soft skills through their involvement in HOSA. As a part of their HOSA requirements, they must attend a board meeting of an outside organization. The EMT students have created their own executive board to run events, fundraise, and prepare for future HOSA conferences.

In spring, the students will be able to test for their national EMT credential, which would cost approximately \$5,000. Students will graduate with CPR, BLS, First Aid, Stop the Bleed, and Bloodborne Pathogens certification.

Students will participate in three events this year. The first is a leadership retreat in Williams, Arizona in October. Second is a leadership conference in Phoenix, then a third conference in collaboration with the Arizona Cardinals. In the spring, students will participate in HOSA competitions related to EMT skills, public speaking, presentation skills, and more.

Michael introduced the work that the EMT students are doing in class, such as making public service announcements in preparation for the HOSA competition. In terms of hard skills, they are studying the heart through dissections and diagrams.
