

Due to falling below the threshold of \$750,000 in federal funding, Nosotros Inc. does not need to complete a single audit. This changes the deadline for submission to November 15th. The current ADM is 305 while staffing has been reduced, so revenue should trend upwards.

One note is that funding for special education has increased from \$61,124 to \$63,292 from state aid. Additionally, the document highlights the funds received from COVID-19 relief projects, which have largely been suspended. Teacher salaries have also increased 5.2% on average.
