Dual enrollment classes have continued growing. Four students will complete WRT101 through Pima Community College this semester. In the spring, six students will enroll in WRT102 with half of the Junior class enrolling in WRT101. Two students are going to take College Algebra.

Sports have continued with Boys Basketball. Other activities including the Nosotros Academy EMT students attended a Arizona HOSA (Future Health Professionals), RED ZONE Leadership conference this week, December 12th, 2025. Additionally, the Winter Formal and the Winter Concert are happening next week.

There has been a focus on EL and IEP students through tutoring and improved instruction.

The goal of the program is to recruit high school students to Ivy League universities. Our intention is to increase college preparation and to involve Nosotros Academy students.
